Introduction – An assumption that Two House is Contrary to Paul's teaching

According to the Wikipedia entry on Two House Theology, critiques will say this...

"There are others, who are more moderate in their approach to the Two House controversy, who choose to see it as an overlooked element in the eschatological restoration of Israel. They disregard the speculation and "pseudohistory" from British-Israel and other Christian Identity groups, adhering to Paul's directive not to pay attention to "endless genealogies which promote speculations rather than the divine training that is in faith" (1Ti 1:4, RSV)."

Endless Genealogy Accusation, My Response

In various articles like, "Shomer-Habrit", article #2, I state my legal status, here it is in part ...

Legal Status: Here is how I would articulate mine: <u>I operate under the assumption that I'm from the House of Israel...</u>

In "Shomer-Habrit" I also discuss Two House and how important it is to me.

So I have a question to the critiques of two house, based on my stated legal status, am I involved in "endless genealogies" and therefore in conflict with Paul (1Ti 1:4 & Tit 3:9)? The extent of my genealogy is to state an assumption of being from the House of Israel. Tit 3:9

But avoid foolish questions, and genealogies, and contentions, and strivings about the law; for they are unprofitable and vain.

Tit 3:9 RSTNE

But avoid foolish endless questions, and stories of genealogies, and contentions, and quarrels with the Sophrim; ⁶³⁵⁰ for they are unprofitable and vain. ⁶³⁵¹
